### **Police Chief Uses Technology, Planning to Reduce Scottsdale Crime**

Scottsdale has experienced a double digit reduction in crime, and the city's per capita crime rate is lower today than it was in 1975. That's what Scottsdale Police Chief Alan Rodbell told chapter members during his talk as guest speaker at the March luncheon.

Chief Rodbell, a veteran of more than 30 years in law enforcement, said he focused on three priorities when he became police chief:

1. Technology. He said police agencies had traditionally been on the short end of technical development, but his department's use of tech systems has greatly improved efficiency.
2. Calls for service. He noted that not all calls are the same, but he has used technology to measure workload and assign officers to the street as needed.
3. Strategic planning. The department had a plan but it was inefficient. He drew a plan that assigned responsibilities and deadlines, and it undergoes frequent reviews and updates.

The chief also noted that information sharing internally and among jurisdictions has improved greatly. One result was the low incidence of problems at such recent high profile events as the Super Bowl and NBA All Star Game.



## Legislative Update

### Storming the Hill

We will be departing on April 18 for Washington, D.C., to attend a MOAA Board of Directors meeting and MOAA's annual Council President's Symposium and Storming the Hill session. We are still working to firm up our Storming the Hill meetings with our Arizona Senators and Representatives on April 22, but expect to be able to visit all or most of their offices and discuss the issues with them or their key staff members. Unless something new and unexpected comes to light from further analysis of the President's annual budget request, we still plan on focusing our effort on sustaining the defense budget to fund both people and weapons, barring disproportional military/veteran health fee increases and eliminating financial penalties for military caused disabilities and deaths (SBP-DIC offset and Concurrent Receipt issues).

#### MOAA Helps Head-off Faulty Proposal

The details of the FY2010 President's budget request will continue to unfold throughout much of April. One interesting facet that came to light in early March was a draft plan that would have the VA bill veteran's health insurance plans for the cost of treating their service-connected injuries and illnesses. I am sure that most of you read about it in the papers, but you may not have heard the rest of the story. MOAA was actively involved in heading off this ill-conceived effort before it really got off the ground. Our President, VADM (Ret) Norb Ryan, was one of 11 signers of a letter to the President sent on February 27 which described why this was a bad idea and asked for a meeting with the President if he planned to pursue it. At the President's invitation VADM Ryan and the corresponding leaders of the other 10 veteran's service organizations who signed the letter met with the President, his chief of staff and the VA Secretary on March 16 and later with his chief of staff on March 18.

In his weekly letter to MOAA board members VADM Ryan gave us his personal take on the events. He stated that he thought the President was ill-served by his staff for getting him to include such a lightning rod in his first cut of the

budget. However, he was impressed by the President's sincerity in taking the initiative to talk about it in person, the intelligent questions he asked and his ultimate good sense in making what had to be an embarrassing decision to drop the initiative.

Here is once again an example of why we need to continue to actively support MOAA and other veterans' service organizations. If it were not for the high esteem in which the organization is held, MOAA would not have been able to help rebut this issue, and another ill-conceived idea could have come to pass.

#### Tracking Critical State Veterans Issues

On the Arizona state level, the legislature is still focused on the FY2010 budget. The Senate is still not hearing any of the 20 veteran-related bills that had been introduced until after the budget is in hand. The House, on the other hand, has continued to hold committee hearings on its bills. Of the original 10 House veteran-related bills, three (including two we opposed) were dropped for no activity. Another was added through a provision called a "strike all amendment" which struck all the language of a previously introduced bill on repealing business personal property tax and added a desire of the Arizona Legislature to build a state veterans' cemetery in Tucson.

We will continue to track these bills, but our primary concern remains focused on how the state budget problems will affect the Arizona Veterans Services Department. All departments have been asked to provide an assessment of what impact there would be if their department budgets were cut in 5% increments from 5% to

25%. The department could handle the lesser number but would be pretty much devastated at the higher ones. Of particular concerns are funding to maintain the staff of 40 Veteran Benefit Counselors (VBCs) which have been added after much effort over the last two years and the state share of construction funding for a proposed veterans' home in Tucson. The VBCs are state employees who help veterans get through the complex process of applying for and qualifying for federal VA benefits. They not only help our veterans, but also bring millions of

dollars of federal VA funding into the state each year.

Our state-required 35% share of funding for a new veterans' home is \$10 million, which has been in the budget for the last two years. We have been unofficially advised by the VA that the stimulus package will fund 68 projects on the VA construction priority list with the Tucson home sitting at number 67. This is really good news provided that the VA priority list doesn't get changed and, most importantly, that the state keeps its 35% required share in the state budget. Without it, we drop off of the VA list altogether. We will see how this develops over the next few weeks.

## JROTC Medal Presentations Set to Begin at High Schools

Many thanks to the chapter members who volunteered to represent the Arizona Chapter at JROTC award ceremonies at 17 Valley high schools this year.

The volunteers will present medals to JROTC cadets in their junior year who have been recommended by their instructors based on the cadets' potential for military leadership.

This program is another way MOAA recognizes standout students and encourages them to excel in their lives.

Presentations will begin April 17 and continue through mid-May in ceremonies at the schools.

JROTC Awards Chairman Terry Tassin notes that any presenter who has a conflict should contact him at 623-931-1546 to arrange an alternate presenter.
