# Class of 2010 AZ Veterans Hall of Fame Inductees

Two Arizona Chapter members were among 20 honorees inducted into the Arizona Veterans Hall of Fame in ceremonies October 29.

Col Gary Fredricks, USAF (Ret), above left, and COL Webb Ellis, USA (Ret), are the newest AZVHOF members. Those selected are veterans who served the country in the military and continued to serve with deeds and accomplishments beyond their military service.

Gary retired from active service in 1984, then followed a civilian career in the defense electronics industry, retiring in 2003 from Raytheon as production program manager for Tomahawk missiles. He is a life member of MOAA and the Air Force Association and is a past president of the Arizona Council of MOAA Chapters and United Arizona Veterans. He is currently our chapter's legislative chairman and is a member of the Arizona Veterans' Advisory Commission and the national MOAA board.

Webb retired from military service in 1992. He was chairman of the bicentennial project to restore the Pioneer/Military Cemetery Historical Site and served on the Arizona Veterans' Service Advisory Commission from 2002-08, including chairman 2004-07. He was chairman and vice chairman of the United Arizona Veterans and led UAV's implementation of the Arizona Veterans' Hall of Fame in 2001.

#### **Burial Benefits**

While you may qualify as a veteran for certain burial benefits, they do not come automatically. Some of the benefits and some of the limitations are described below:

#### U.S. Department Of Veterans Affairs (VA) Benefits Do Not Cover All the Funeral Or Cremation Arrangements Of Honorably **Discharged Veterans.**

There is a common belief that the VA pays for all the funeral or cremation arrangements of an honorably discharged veteran. However. reimbursement for funeral or cremation service expenses is limited, and usually only applies to veterans who retire from the Armed Services, or were disabled due to a service-related injury, or died in a VA hospital or while in a nursing home under VA contract. Only the VA can rule on your exact benefits.

### You Will Need Documentation To Verify Military Service.

A "Report of Separation From the Armed Forces of the United States" (discharge papers) is normally required to verify military service. In most cases, this report is the "DD 214." If this report or its equivalent is not available, a "Request Pertaining To Military Records, Standard Form 180" can be sent to the Military National Personnel Record Center.

### A Veteran's Family Must Request A United States Flag.

A flag is provided at no cost to drape the casket or accompany the urn of a deceased veteran. Generally, the flag is given to the next of kin.

#### Military Funeral Honors Ceremonies Must Be Scheduled In Advance.

Upon the family's request, the law requires that every eligible veteran receive a military funeral honors ceremony, which includes the folding and presentation of the United States flag and the playing of "Taps." The ceremony is performed by a military funeral honors detail consisting of two or more uniformed military persons and at least one person who is a member of the veteran's branch of the Armed Forces.

#### Veterans' Caskets Are Not Free.

As a standard policy, neither the VA nor the various branches of service provide a free casket for a deceased veteran, unless death occurs while on active duty.

#### If You Choose Not To Be Buried In a VA **National Cemetery, Monetary Burial Benefits** Are Limited.

Veterans buried in a private cemetery may be eligible to receive a partial reimbursement for their burial costs. For non-service-related deaths, a burial expense allowance (up to \$300) and a plot allowance (up to \$300) may be given. If a death is service-related, benefits up to \$2,000 may be paid for burial expenses. Any deceased veteran discharged under conditions other than dishonorable is eligible for a standard government headstone or marker.

These benefits are the principal benefits listed in the Veterans Planning Guide published by Dignity Memorial Network. Inc. You can obtain additional information at 1-866-508-5834.

#### **Legislative Update**

As *The Sentinel* goes to press this month, nothing has changed significantly on the legislative front from last month's report. We await the results of the election, and we hope you exercised your right to vote. No matter the outcome, the new legislatures at both the state and federal levels will face daunting tasks. Currently, MOAA is requesting our help in alerting our national legislators to the importance of enacting the FY2010 Defense Authorization Bill without delay. You can do this easily by sending a pre-prepared e-mail through our newly designed MOAA website at www.moaa.org.

#### **Our Members Make a Difference**

With the absence of significant news, I would like to take this opportunity to recognize and thank two of our chapter members for the good work they do, which you may not be aware of.

First, it was just announced in late October that the Phoenix School of Law, Veterans' Legal Clinic, is now open and ready to take inquiries from veterans on general civil and consumer legal issues. The clinic is a free service to veterans and is staffed by students from the school. The school plans on expanding assistance to criminal and domestic law matters in the future. They can be contacted at vetsclinic@phoenixlaw.edu.

Additionally, the State Bar has implemented a standing committee for military personnel. veterans and their Several attorneys and other experts have been assigned to subcommittees. includina legislation, programs and services, family law, veterans' courts, education and training and minorities. This is still a work in progress that we will see more from in the not too distant future. Also, there is planning in place that we hope will eventually lead to the establishment of Veteran Treatment Courts as a part of our court system. The purpose of this would be to enable veterans to receive fair treatment and the services they earned through carefully monitored court ordered rehabilitation and counseling in order to help overcome the ill effects of service-related problems in lieu of strictly disciplinary actions.

Our own chapter 1st vice president, **Gregg Maxon**, has been one of the key leaders and driving forces in these initiatives. Thank you, Gregg, for all you do.

Second, we tend to concentrate on the annual Defense Authorization Bill as a legislative vehicle for military/veteran benefits. There is a companion authorization bill that funds the Veterans Administration. there is still much to be done, over the last few years we have seen significant improvements enacted through this bill as well. There has been about a 60% increase in VA discretionary funding, adding significantly to veterans' health care and services. Equally important, Congress authorized advance appropriations for the VA. providing a stable uninterrupted source of funding for medical care to veterans one year in advance.

Many of these VA initiatives can be traced back to the House Committee on Veterans' Affairs. The day job of another one of our chapter members, Corey Harris, is serving on the local staff of one of our representatives who has been serving on that committee during his term in Washington. If you attended our chapter picnic, you could see Corey wearing his Arizona Army National Guard uniform, as he is a lieutenant there who just received at least a temporary reprieve from an imminent assignment back to Afghanistan. Additionally, I see Corey frequently at meetings of the Unified Arizona Veterans and the Arizona Veterans' Advisory Service Commission in his quest to stay current on issues affecting Arizona veterans. Corey left the picnic with a handfull of MOAA membership applications, which he intends to use in persuading other Arizona National Guard members on the value of MOAA membership. So, thank you very much, Corey, for all you do as well.



#### NOTICE OF PROPOSED CHANGES TO AZ CHAPTER MOAA BYLAWS SUBMITTED 11/1/2010

The following are changes to be voted on at the November General membership meeting. Recommended changes are **in red** with proposed deletions <u>underlined in blue</u>. Notice is hereby given that a motion will be made at the November general membership meeting to modify the Chapter bylaws as follows.

Article XI – Amendments, provides for Chapter bylaws to be amended as follows.

**Section 1.** The bylaws may be amended, repealed, or altered in whole or in part by a two-thirds vote of the membership present at any duly organized meeting of the Chapter, providing that a copy of any amendment proposed for consideration has been mailed to each member qualified to vote at least 15 days before the meeting.

#### **ARTICLE II - PURPOSES**

**Section 1.** The purposes of the Chapter shall be to promote the <u>purposes and</u> objectives of the Military Officers Association of America (MOAA); stimulate love of our country and the flag; defend the honor, integrity, and supremacy of our National Government and the Constitution of the United States; advocate military forces adequate to the defense of our country; foster fraternal relations among retired, active, and former officers of the uniformed Services and their National Guard or reserve components; protect the rights and interests of active duty, retired, reserve, and National Guard personnel of the uniformed Services and their dependents and survivors; provide useful services for members and their dependents and survivors; and serve the community and the nation.

#### **ARTICLE III - STATUS**

Section 1. The Chapter shall be a nonprofit organization, operated exclusively for the purposes specified in Article II above.

#### ARTICLE V - DUES

**Section 5.** A new member recruited anytime between 1 January and 30 June will not be charged dues for that calendar year. Anyone recruited between 1 July and 31 December will not be charged dues for that calendar year or the following year.

Section 6. No member shall be assessed by the Chapter for any purpose other than annual dues.

#### ARTICLE IX – OFFICERS

**Section 7.** The secretary shall provide timely written notification of all meetings of the Chapter and of the board of directors and will maintain a record of all proceedings. The secretary shall also carry out these duties: <u>maintain the membership records</u>; prepare such correspondence as might be required; maintain the Chapter's correspondence files; and safeguard all important records, documents, and valuable equipment belonging to the Chapter. Further, the secretary shall perform such other duties as are commensurate with the office or as might be assigned by the board of directors or by the president.

**Section 8.** The treasurer shall maintain a record of all sums received and expended by the Chapter, collect the members' annual dues, make such disbursements as authorized by the Chapter or the board of directors, deposit all sums received in the financial institutions approved by the board of directors, and make a financial report at the annual meeting or when called upon by the president. Funds may be drawn from the account in the financial institution upon the signature of the treasurer, president or another designated board member. The funds, books, and vouchers in the custody of the treasurer shall at all times be subject to inspection and verification by the board of directors.

#### **ARTICLE X – COMMITTEES**

Section 2. The standing committees of the Chapter shall include membership, programs, scholarship, ROTC Awards, arrangements, legislative, and personal affairs. The membership committee shall secure new members to strengthen the organization. The program committee shall be responsible for suitable programs for all meetings. The scholarship committee shall be responsible for the Chapter's Scholarship Program. The ROTC Awards committee shall be responsible for the ROTC Medals program. The arrangements committee shall be responsible for making proper arrangements for all meetings. The legislative committee shall protect the rights and privileges of members by maintaining close contact with current and proposed legislative actions, will advise members accordingly, and will recommend action. The personal affairs committee will advise members and families of deceased members when in need as to their rights and privileges, and will assist members in securing veterans' and other benefits. Special committee assignments shall consist of a chaplain, a historian, a photographer, web master, and a newsletter editor in addition to other assignments which might be advisable.

**Section 3.** During At least 60 days before the May annual meeting, the board of directors shall appoint a nominating committee consisting of five three regular members to nominate develop a slate of candidates for the elective offices. The sitting second Vice President shall serve as the Chairman of the nominating committee. One sitting regular board member and one non-elected regular member shall be appointed to serve as the other members of this committee. The committee shall notify the secretary in writing, no later than the October September board of directors meeting, of its proposed slate of officers and directors for the next calendar year. The secretary shall list in the chapter's October and November newsletters the nominated candidates for the elected offices.

**Section 4.** The entire slate recommended by the nominating committee will be verbally presented to those attending the annual meeting in November. In addition, further nominations from the floor will be accepted at that time. Closure of the nominations shall be followed by voting on the slate in accordance with Article V.
