### Legislation

In the week ending March 22nd, the House Budget Committee made history by including over half-a-billion dollars in its FY 2003 Budget Resolution, as an initial down payment toward eventually ending the dollar-for-dollar offset of military retired pay for VA disability compensation. On Wednesday, the full House passed its version of the Budget Resolution, which included partial funding.

On Thursday, the Senate Budget Committee drafted its own version of the Budget Resolution, and followed the House's lead on the concurrent receipt funding. The committee's action, on top of that already taken by the House, virtually assures that some real progress will be made in FY 2003.

In discussions with TROA National, it was learned that current legislation is directed toward the 70% and greater disabled, with elimination of the current 4-year limit. This looks like real progress. We will be calling on all of you for your letters, post cards, calls and emails to make this happen.

At the March 2nd UAV meeting, a Coast Guard Flag was presented to the Arizona Department of Veterans Services by the Arizona Chapter to fly over the State Capital on Coast Guard Day, which is August 4th. Coast Guard veterans Jim Seidl, Dan Conway, and John Gerometta plus USAF veteran Frank Birtciel paid for the flag. Frank claims that we were never on Ocean Station position, but despite this he was able to get to Spain with our inaccurate fixes. He contributed to the flag anyway.

It was announced that day care for veterans will be available at the Veterans Home starting April 15th at a cost of \$8.00 per hour or \$50.00 per day for those veterans who need such care. ### NOTICE OF PROPOSED CHANGES TO BYLAWS

**Article XI - Amendments**, provides for Chapter bylaws to be amended as follows:

**Section 1.** The bylaws may be amended, repealed, or altered in whole or in part by a two-thirds vote of the membership present at any duly organized meeting of the Chapter, providing that a copy of any amendment proposed for consideration has been mailed to each member qualified to vote at least 15 days before the meeting.

Notice is hereby given that a motion will be made at the April membership meeting to amend **Article X - Committees**, to add a scholarship committee to standing committees by adding the words shown in **bold type** to **Section 2.** as follows:

The standing committees of the Chapter shall include membership, programs, **scholarship**, arrangements, legislative, and personal affairs. The membership committee shall secure new members to strengthen the organization. The program committee shall be responsible for suitable programs for all meetings. **The scholarship committee shall be responsible for the TROA ROTC Medals program, and the Chapter's Scholarship Program.** The arrangements committee shall be responsible for making proper arrangements for all meetings. The legislative committee shall protect the rights and privileges of members by maintaining close contact with current and proposed legislative actions, will advise members accordingly, and will recommend action. The personal affairs committee will advise members and families of deceased members when in need as to their rights and privileges, and will assist members in securing veterans' and other benefits. Special committee assignments shall consist of a chaplain, historian, photographer, and newsletter editor in addition to other assignments, which might be advisable.

## The Dignity Memorial Vietnam Wall

19 – 21 April 2002

Green Acres Mortuary and Cemetery, located at 401 N. Hayden Rd. Scottsdale, AZ has been selected as one of 23 sites across the nation to showcase a 240-foot, three-quarter sized replica of the Vietnam Wall in Washington, D.C.

The Wall contains more than 58,000 names and is dedicated to all Americans who served in Vietnam. It also honors all Veterans of the United States Armed Forces.

### Objectives:

This project was developed in an effort to give all Americans an opportunity to have The Vietnam Wall Experience, even though they may not have the chance to visit the original memorial in Washington, D.C.

One of the primary objectives is to increase awareness in the community. The Wall is our gift to help heal a nation.
