Legislative Update

On the national legislative scene MOAA reports that our staff, as a part of The Military Coalition, have been briefing the joint committee of Congress charged with rationalizing the different House and Senate versions of the FY2008 Defense Authorization Bill. As always, what gets in and what doesn't will be a matter of what has the highest priority in the eyes of the joint I am confident that our MOAA conference. Washington staff fully understands our priorities and is more than capable of articulating them. They are not at the present time asking for our help, so we need to be patient and see what happens. You can view our collective priorities at www.moaa.org if you wish.

At the state level, there isn't any specific legislative activity at present. The state legislature approved the 2008 budget and the governor signed it some time last summer. The state legislature will not be in session again until January 2008. However, that does not mean we should all be relaxed thinking all is well.

If you have been reading the papers, you will know that the state of Arizona currently expects a shortfall in revenue from that projected when the 2008 budget was approved in the range of \$600 million. A recent article in the Arizona Republic highlighted the issue in relation to a probable curtailment in Veteran's Outreach Expos. Two years ago, a Veterans Task Force chartered by the governor recommended several initiatives, including these expos, to improve veteran's benefits for Arizonans. The significant initiatives were then included in either the FY 2007 or FY2008 budgets and things were looking like we might begin to catch up with what other states are doing for veterans.

Now along comes the revenue shortfall. The governor has told her departments to come back to her with how they will absorb a 5% budget reduction to account for the \$600 million shortfall. For the Department of Veteran's Services, a relatively small department, this amounts to \$500 thousand. As it now stands, some of the expected gains coming from the task force effort may well not make it. Of particular concern are

the potential for not hiring all of the Veteran Benefit Counselors that have been authorized and the potential to lose state matching funding, and consequently federal funding, for a Veterans Home in Tucson. Also, a potential issue is the state funding to help support the operation of the existing Veterans Home in Phoenix. You should recall that earlier this year, issues with this home cost the then director of Arizona Veterans Services his job. I can attest to the fact that this was at least in part due to an inadequate state budget.

As the Chairman of Unified Arizona Veterans and a member of the Arizona Veterans Advisory Service Commission, I will be meeting with the Director, Department of Arizona Veteran's Services and will be closely monitoring this issue over the next few weeks. I urge you to watch the news for developments. We need to try to find ways of deflecting the shortfall to some other department's budget line.

TOPS Tips

I had a job over at the Scottsdale Air Park a few years ago. It was a good job, a good group of young folks and just about everyone was pretty pleased with the environment. I was the only one who was "retired" and thought the second career was just right for me. I still do.

However, it wasn't the same for my youthful peers, and more than likely, it won't be the same for folks entering the job market today. Unlike the jobs of yore when a person would climb the "ladder of success" to earn a "retirement" or the proverbial gold watch, the careers of today oft times shun the ladder, and appear more like a spider web. People can climb up, but they frequently shift to the left and right also as they navigate amongst the numerous iob opportunities that present themselves. 401K's are the retirement plan now, and people carry theirs with them as they move about. So, the important item to have nearby when opportunities arise is the handy dandy, well written, carefully considered, very current - resume.

If you have gotten this far in this column you either have a resume, are beginning to prepare one, or have a son or daughter you'd like to have one (I can relate to that!). And generally speaking, after the careful construction (write it, brainstorm your past accomplishments; re-write it, add your education and work history, etc) process, folks continue to make mistakes. Make one mistake, and chances are, the prospective employer will simply dump it for you. Several common mistakes to avoid are:

- Do not depend upon "spell check". Often times a typographical error is not a spelling error (Spill Check).
- Do use a cover letter. Most managers expect the courtesy of a proper cover letter. Better yet, this provides you with an opportunity to underscore your qualifications or focus interest upon you.
- Be relevant! Tailor your resume to the

position you are applying for. Managers avoid generic resumes at all costs – and you should also.

- You made an impact! So say it. Skip the job descriptions and address your accomplishments. You may have implemented cost saving measures what was the dollar amount of cost avoidances? Perhaps you improved processes, if so, how many man-hours or dollars were saved?.
- Black and White works fine: Use black ink and white or off-white paper. Avoid fancy colored papers or the use of spiffy fonts, and do not paste your photograph onto it either. Your cover letter and resume paper and font should match.
- Your Objective: Your objective ultimately has to be one that benefits you and the prospective employer. Specify your accomplishments that match the business needs of the manager, not one that states you hope to gain experience which will prepare you for your next career move.
- Be accurate. Background checks are routinely conducted, so, use your correct titles and dates of employment. Any embellishments that are disclosed will only result in lost opportunities for you.
- Save it! Save it for the interview stage, if they ask. The resume is not the place to share that you were the victim of a reduction in force, were fired, or why you quit. By the same token, hobbies and preferred methods of recreation, height and weight, do not belong on a resume.
- And lastly, remember that a single page for your cover letter and two more pages for your resume is the limit.
