January 2009

The Arizona Chapter kicked off the new year with installation of officers and a fascinating presentation by a World War II aviation historian.

Guest speaker Dr. Bill Wolf of Carefree, a retired dentist and World War II aviation historian, shared stories and items from his extensive collection of WW II memorabilia with the 58 members and guests at the luncheon gathering. He has written eight books on air combat in the war and has a ninth scheduled for publication this year. His collection of wartime artifacts and documents is possibly the largest private collection in the world.

The Chapter resumed luncheon meetings in September with a timely and enlightening program following a summer break. Col. Gregg Davies, commander of the 214th Reconnaissance Group, based at Davis-Monthan AFB in Tucson, described his unit's role in operating MQ-1 Predator unmanned aerial vehicles in the skies over Afghanistan.

While based in Arizona, the 214th launches and "flies" the Predators, which are based in Afghanistan, through a fiber optic and satellite network. The Predators provide real-time reconnaissance and surveillance to troops on the ground and also carry precision weapons to launch on selected targets. Col. Davies described the mission and related several of the actions involving the Predator. His presentation was very informative and drew a number of questions from the 64 members and guests at the meeting.


