Holocaust Survivor to Describe His Incredible Survival Story

This is a "don't miss" program, the opportunity to hear first-hand from one who survived one of history's most horrific examples of man's inhumanity to man, the World War II Holocaust.

Dr. Alexander White was just 16 when the Nazis invaded Poland. Of 34 of his extended family members, only he and two cousins survived.



He was saved by being one of "Schindler's Jews," an estimated 1,200 Jews freed from the concentration camps by being employed in Oskar Schindler's factories. This episode became prominent in the movie "Schindler's List."

After the war, Dr. White attended medical school,

moved to the U.S. and served in the Army Medical Corps. He became associate professor of medicine at the Chicago Medical School and practiced medicine in that city for 40 years. He retired to Scottsdale 15 years ago.






Hall of Fame Class of 2013

Legislative Update by Gary Fredricks National Legislative Chair

More Kicking the Can

As I'm sure you are all aware, Congress managed to finally kick the can down the road once again in mid-October. They passed another "Continuing Resolution" that re-instated funding for national government operations after their gridlock had caused the government to be effectively shut down for a little over two weeks. This "Continuing Resolution" lasts through January 15, 2014, and the legislation also pushed the national debt limit issue out into the February timeframe. Recall that congressional gridlock last year resulted in a series of continuing resolutions that lasted through the end of the last fiscal year on September 30 with Congress never passing any appropriations bills.

Still a Ways to Go

So, where are we now? The just-passed legislation also required bipartisan action from the House and Senate to produce an FY2014 budget by December 13, which just happens to be just before Congress is normally scheduled to start their holiday break that runs into early January. Recall that the two previous year's efforts at this kind of approach have not been successful. Also, in March the House passed an FY2014 budget and the Senate, for the first time in four years, also passed one. However, they were very different from each other and from President's budget request. significant progress from the new initiative, they remain so today.

Defense Authorization Bill Stalled

In June the House passed its version of an FY2014 Defense Authorization Bill as did the Senate Armed Services Committee. The two have significant differences, and the Senate has still not taken any final action to pass their version of the bill. So, the authorization bill remains in limbo and "sequestration," which would require approximately a \$52 billion dollar FY2014 reduction in the defense appropriations, is still on the record.

The President's FY 2014 budget request,

submitted last April, assumed that sequestration would somehow be dealt with and did not the contain the reductions required bν sequestration law. Even with that, it still contained some significant hits to our earned benefits. Some of those were proposals to use a "chained CPI" in lieu of the normal inflation adjustments to military retired pay, means testing (reducing benefits for higher income) for health care benefits, charging an enrollment fee each year for TRICARE for Life and significantly increasing co-pays for pharmacy prescriptions. So, if Congress does manage to get through this financial maze, we may not like what we see.

What About Medicare/TRICARE Payments?

With all this going on in Congress several other issues also need action. One of those is the issue of Medicare/TRICARE payments to doctors. Congress must take action by December 31 to avoid a \$24.4 billion dollar reduction to these payments caused by a law that is generally accepted as being faulty but for which Congress has been unwilling to deal with permanently due to it being a significant unrecognized hit to the debt. For the last several years Congress has managed to kick this can down the road one year at a time and keep doctors interested in treating individuals covered by these programs. Let's hope they find a way to deal with it again.

Tips for Preventing Identity Theft

The following article was taken from the Sept 4th MOAA News Exchange. It is repeated here because of its importance, especially for those who travel with their computers and didn't open the News Exchange article.

The Federal Trade Commission says identity theft is the most frequent consumer complaint it receives, with 18 percent of complaints related to it. Seven percent of U.S. households have reported some type of identity theft, with the average financial loss per incident averaging \$4,930. according to Javelin Strategy Research. On the other hand, a study by Microsoft Research titled "Sex, Lies and Consumer Surveys" concluded that loss estimates from identity theft are greatly exaggerated. The reality is theft of your credit card, bank account, or other financial information can cost you time and money as well as damage your credit rating. Identity theft and other hacking are perpetuated by teenage vandals, small-time crooks, organized crime gangs, terrorist cells and computer geniuses hired by governments.

A statement from Google gives more legitimacy to the concerns. Consumer Watchdog had filed a class action lawsuit against Google for scanning keywords in Gmail e-mails so it can send better targeted ads to users. In a motion to dismiss that suit, one of Google's lawyers, citing previous court rulings, indicated that e-mail users should have no expectation of privacy. Savvy users know this isn't limited to Gmail, and they should safeguard their privacy online. Consider these precautions:

- Keep current with operating system and program updates.
- Use firewall and anti-virus software, and keep it current, whether a pay service such a Norton 360 or a free service such as AVG Free combined with your operating system's own firewall.
- Set your browser to block pop-up windows, being especially wary of updating software via a pop-up when you connect to a site.
- Make sure any web page on which you're

doing anything sensitive is HTTPS protected (the web address begins with "https").

• Stick with two-factor authentication when it's available (to log in you have to answer a question or receive a text along with typing a password). With bank, credit card, and other financial sites, opt for long passphrases instead of short passwords.

Computing from the road seems to elicit the most scare stories. There are rogue Wi-Fi access points, compromised Wi-Fi access points, hacked hotel networks, pop-up drive-by attacks, forged SSL certificates, JavaScript attacks, keystroke logging, man-in-the-middle attacks, on and on. It's almost enough to wish we were back using typewriters and the Postal Service.

Part of the security worry out there appears to be theoretical, some of it no doubt fanned by security firms trying to drum up business for themselves by publicizing the latest potential vulnerability in a program or service. Still, it makes sense to be careful.

When on the road, take these precautions:

- Confirm the correct name of any public Wi-Fi network you're supposed to connect to.
- Designate public Wi-Fi connections as public networks to help keep you invisible and prevent file sharing.
- Do online banking, online bill paying, and online shopping only when you have WPA2protected Wi-Fi rather than the older WPA or WEP standards.
- Consider using a virtual private network (VPN) service, examples including HotSpot Shield and Private Wi-Fi. VPNs supply their own tunnels within the larger Internet that your data travels through. They're advertised as providing the best protection on public Wi-Fi networks, but they aren't always totally secure either.
- Avoid sensitive financial tasks on the road unless you have both WPA2-protected Wi-Fi and VPN.


