Pete Palmer, BG USA, (Ret.), is director of the EDGE Innovation Network at General Dynamics in Mesa. The EDGE program brings together government, industry, academia and non-profit organizations to collaborate on rapid development and delivery of new technologies to warfighters and

first responders.

He is a 32-year Army veteran with a wide range of infantry assignments, including heading a simulation-based virtual training environment for commanders and staffs. He is using his experience to keep the EDGE network at the forefront of understanding the technology gaps warfighters face and developing new ways for them to assess and manage information.

## February Guest Speaker

### **A Survival Story That Has Become an Inspiration to Others**

When George Burk joined 13 others and boarded a military transport in May 1970, it was to be a routine flight to Spokane, Washington, to conduct an operational analysis.

Moments after takeoff the flight went from routine to nightmare when the aircraft experienced rapid decompression and structural failure and crashed in the hills near Napa, California. George was the only survivor.

Capt George Burk, USAF (Ret), retold his story of tragedy and survival as guest speaker at the February luncheon.

Though he survived the crash, he suffered burns over 65% of his body, broken bones and internal injuries. He was not expected to live.

He spent months in intensive care, endured 36 operations, reconstructive surgery and skin grafts accompanied by painful rehabilitation. He had two near death experiences.

The fact that he even lived through the aftermath of the crash was due to a quirk of fate. The rancher who found George shortly after the crash and summoned help was taking a different route than usual for his daily check of his property. It took him by the crash site.

George said he knew he was dying, but "I tried to inspire myself to stay alive." He told himself, "I'm not quitting."

That will to live carried him through the difficult path to recovery.

When he was recovered enough to begin the next chapter in life, George, who had been medically retired from the Air Force, learned a lesson: "No one wanted to hire a Vietnam veteran with disabilities."

Instead, he found a calling as a motivational speaker on such subjects as overcoming adversity and quality in life and work. He has given keynote addresses, conducted training seminars and has spoken at West Point and the Naval Academy, as well as a wide variety of other organizations.

"One question that is always asked is 'do you still fly in airplanes.' The answer is yes." he said. One of the messages he gives is this one: "When you're sick, dying is easy. It's the living that's hard."

"Life is nothing but a series of adjustments," he told his audience.

"I believe in God," he said. "I fear no one but God. I was not supposed to live beyond day 14, but last July I turned 73.

"I'm not lucky; I'm blessed," he said.

George has been sharing his inspiring message for 35 years. He is now a Scottsdale resident and also is a fellow member of the Arizona Chapter.

## Member's Spotlight

### AF Pilot Flies with the Navy

Ron Perkins' brother, a Navy flier, gave him some advice when Ron had a career decision to make.

So naturally, Ron ignored it.

An Air Force pilot, Ron was selected for an exchange program with the Navy, where he would live the Navy life and fly the Navy's A-6 Intruder.

His brother tried to discourage him. Among the warnings, "it's dangerous on the flight deck, and there are no divert fields."

"So I did it," Ron told members as our spotlight speaker in February.

He flew with the Navy, went to sea with them and made 130 carrier landings in the A-6, one third of them at night.

But it was different. Ron was used to flying the Air Force's F-111 a supersonic aircraft. The A-6 is subsonic and very hands-on to fly. And he was accustomed to runways several thousand feet long.

On a carrier the landing area is 500 feet, the takeoff is at 300 feet. On landing, the deck looks about the size of a postage stamp, it's rolling and going away from the pilot. And of course there's no divert field.

"There were nights when I kissed the deck after a landing," he said.

The trick on landing is to connect the aircraft tail hook with a catch wire. There are four wires, and if they're all missed, there's a mesh barrier. If the aircraft crashes through the barrier, there's still another option — eject.

Ron spent two and a half years with the Navy, "but I was glad to get back to the Air Force," he said.

The way it works is that your cell phone rings just once, then shows you've missed a call. **DO NOT CALL BACK** unless you recognize the number. If you do, within three seconds your entire contact list could be stolen. In addition, you may also be charged a fee on your monthly bill, most frequently \$19.95, but it could be more or less.

## Legislative Update

### Calm Before the Storm?

After a flurry of activity late last year and early this year, things have gotten pretty quiet lately in Washington. This could well be the calm before the storm as attention changes from completing long overdue action for FY2014 to beginning congressional action this calendar year to put things in place for FY2015. On the other hand, I'm reminded that this is an election year when politics typically prevails over progress.

#### MOAA Chimes In

Last month we reported that Congress had passed a budget that applied not only to this fiscal year, but also to next, negating the requirement to pass a budget during this calendar year. That was good, but it also contained the 1% cut to military retired pay for all those under age 62. Thanks to MOAA's extensive advocacy both directly and through our co-chairmanship of The Military Coalition and the good work of virtually all military/veterans associations, that action has been mitigated substantially, but not completely. MOAA chapters are the recognized heart and soul of legislative advocacy through our unique ability to bring grassroots support to the table. That support was very evident in dealing with this issue. MOAA reports that over 295,000 e-mails were sent to Congress on this issue through the MOAA website. While all of these were not chapter members, I'm convinced that most of them were.

#### More Fixes Remain

Unfortunately, some work remains on the issue, since the fixes only applied to current retirees and those entering service prior to January 1, 2014. It remains to be seen how the last part will play out. One possibility is through the congressionally mandated Military Compensation and Retirement Modernization Commission. The Commission report, required by the FY2013 Defense Authorization Bill and originally due in May of this year, has now been delayed by Congress until February 2015, conveniently after this year's elections.

The action that normally kicks off the congressional fiscal year committee and floor work in both houses is the issuance of the president's fiscal year budget request which is supposed to be released the middle of February. This is where MOAA gets a better understanding of where the administration priorities lie and where defense is likely to take a hit. Most recently MOAA has indicated the budget request is now expected on or about March 4. As mentioned

above, Congress has already approved a top level budget for this year, so the president's action really should begin to shed some more light on the details of what the administration expects. Given the presence of a fiscal year budget, it also should directly kick off congressional action in both houses on the FY 2015 Defense Authorization and Appropriations Bills.

#### Priorities for the Year

Given what we know so far, I expect MOAA's primary legislative initiatives for the year to be centered on protecting our earned benefits and avoiding significant increases in health care and pharmacy costs; protecting the interests of our currently serving by advocating for normal pay increase and guarding against premature budget-driven troop reductions, and dealing with some of the other remaining inequities such as the SBP-DIC offset issue. MOAA has already expressed concern over military compensation and benefit issues that could well be in jeopardy over the coming months. They include:

- Capping pay raises or even freezing pay
- Making additional end-strength cuts
- Cutting basic housing allowance
- Reducing the commissary benefit savings
- Means-testing TRICARE fees and establishing TRICARE For Life/TRICARE Standard enrollment fees – and more.

#### At the State Level

The annual state legislative agenda passed another important milestone [February 21](#). On that date bills in both houses needed to have been heard in committee in order to remain actively under consideration without extraordinary action.

Of the 48 bills, resolutions and memorials affecting the military or veterans that the Arizona Department of Veterans Services has been tracking, 20 were not heard, leaving 28 still potentially in the pipeline. Of particular interest, HB 2308 and HB 2402, which would have enhanced the state tax military retired pay exclusion, were not heard in committee. Although similar bills have been introduced over the last couple of years, without some significant veteran lobbying this initiative is not likely to succeed given its impact on the state budget.

On the other hand HB 2457, which would authorize the presiding judge of each county superior court to establish a regional veterans court, is still alive and apparently doing well. One of our own chapter members, Gregg Maxon, is a key advocator of this initiative, and the MOAA Arizona Council of Chapters has been active in promoting it as well.
