Innovation Program Brings the EDGE to the Front Lines

When talented minds from diverse disciplines come together for a common purpose, good things will result.

That's what is happening at the EDGE Innovation Network at General Dynamics in Mesa, a program headed by Pete Palmer, BG USA (Ret).

Pete was guest speaker at the March luncheon, where he described the work being done on projects aimed at improving the tools and systems used by battlefield commanders and first responders.

EDGE focuses on C-4 systems — command, control, computer and communications — which in combination are necessary for success in fast moving, high stress situations.

The program brings in representatives from government, industry, education and business services to develop and improve C-4 systems.

The program now has 450 entities in 14 centers working to that end.

Member's Spotlight

Desert Storm at Ground Level



Lee Lange, Col USMC (Ret), took us to the front lines of the First Gulf War battlefield as our spotlight speaker in March.

Lee was the Weapons Employment Officer with the 2nd Marine Division when it was deployed following Iraq's invasion of Kuwait in 1990.

"I wasn't looking for war, but it found me," he said.

Lee described the obstacles the friendly forces faced — minefields, burning oil wells and Iraqi forces — and how they overcame them. He outlined the troop movement tactics when the ground assault began in February 1991 following the air war, and how they led to the liberation of Kuwait.

The 2nd Division had minimal casualties and equipment losses while destroying nearly 1,000 lraqi tanks, artillery and other heavy weapons and taking 14,000 prisoners.

"We were there to do a job — drive Iraq out of Kuwait," he said. "That's what we did."

"The question is how can we put to gether a collaborative, open network so everyone can advance their capabilities," he



said. "I call it a technology or capability dating service.

"The challenge is to get the right groups so we can actually move and accelerate the capabilities of technology."

Pete also described other challenges such as slow moving bureaucracies, finding the right participants and training users on new systems. "It's a major shift to go from regular telephone ssystems to digital smartphone technology," he said as an example of the training challenges.

Sometimes the right participants don't have the familiar names but do have the pieces that contribute to solutions. "I love small companies," he said. "They can really turn technology."

Things To Do in Fountain Hills While Your Spouses Play Golf

If your husband or wife is playing golf at the chapter tournament May 1, you don't need to be left out.

A variety of activities and sights are found in and around Fountain Hills. You could spend the morning enjoying the Fountain Hills scene, then join your spouse for lunch when the tournament is over around noon.

Here are some examples:

The Alan Cruikshank River of Time Museum at 12901 N. La Montana Blvd. has exhibits recalling the ancient people, explorers, prospectors and soldiers who made an impact on the area. You also can learn how "the dam that never was" brought about the development of Fountain Hills.

The Fountain Hills Public Art Collection consists of sculptures, water features and other artworks, more than 105 of them, that can be seen on downtown streets, plazas, parks, in the Community Center, Town Hall and other public places.

Fountain Hills Public Library has a used book store with hard cover and paperback books ranging in price from 50 cents to \$2. A sculpture garden outside has bench seating and a great view of the fountain. Get a cup of coffee, enjoy the art and read a book until lunchtime.

For the more adventuresome, McDowell Mountain Regional Park, four miles north of town, has many hiking trails that wind through scenic desert landscapes, some less than a mile long and others ranging 1-2 miles and longer. Wildlife sightings are common, and many bird species are found around the three ponds in the park.

If you're feeling lucky, **Fort McDowell Casino** is close by with gaming machines, table games and other diversions.

And don't forget The Fountain, which shoots a water spout up more than 300 feet at the top of the hour beginning at 9 a.m. daily.

Start with breakfast. A couple of suggestions are Flapjacks in the Basha's Center on La Montana Blvd. and DJ's Bagels — real New York bagels and everything that goes with them — on N. Fountain Hills Blvd.

Legislative Update by Gary Fredricks Legislative Chair

'Storming' Priorities Set

MOAA's national Board of Directors met by telephone on March 17 and approved the following "Storming the Hill" issues:

- Sustain military pay and benefits and avoid repeating past mistakes that destabilized the all-volunteer force
- Reject disproportional TRICARE fee increases which shift costs onto beneficiaries while reducing access
- Eliminate catastrophic sequestration cuts which threaten national security
- And address remaining inequities for disabled retirees, survivors and Guard and Reserve personnel

We recognize that the Pentagon is in a tight pinch with sequestration that will only get worse in subsequent years, but we believe some of the personnel cost savings proposed by DOD in the President's annual budget request undo Congress's past decade of work to rebalance military compensation with the extraordinary demands and sacrifices of a military career. The currently requested piecemeal changes by DOD are especially inappropriate since the Military Compensation and Retirement Reform Commission is required to offer an even broader set of proposals early next year.

Preparing to Storm the Hill

We will be "Storming the Hill" on April 9 along with representatives from all 50 states and Puerto Rico. I will be teamed with Al Rossow, President of the Arizona Council of Chapters from Sierra Vista, and John Chernoski, a new MOAA national board member from Green Valley. Al is currently in the process of establishing appointments with the offices of all our Arizona Senators and Congressmen. We are not always able to meet with the principals due to schedule issues, but are always able to deliver our messages to their key staffers.

I hope you took the opportunity of supporting our effort by sending in the MOAA-suggested email messages contained in our periodic Legislative Updates. All these messages count and help to raise awareness of our issues with our congressional representatives. If you are not receiving these important MOAA messages, go to www.moaa.org under the "Take Action" tab and you can find easy ways of signing up to get them.

Progress with State Budget

As *The Sentinel* goes to press this month the state legislature seems to be making unusually fast progress with a budget for the coming fiscal year. Traditionally, this is the long pole in the state legislative tent with various other bills falling in line quickly after the budget is settled.

There have been some 48 bills, resolutions and memorials affecting the Arizona veteran/military community that merited tracking by the Arizona Department of Veterans Services (ADVS). As you will recall, the bills are required to meet several review/approval milestones in order to remain active and progress through the legislative process.

Some Losses on Veteran-Related Bills

As of late March, only 20 seem to have survived thus far. Of particular note the two bills dealing with tax exemption of retired military pay, HB 2308 and HB 2402, dropped out early on. HB 2147 that would have provided a tax credit to businesses hiring veterans, HB 2177 that would have provided ADVS with funding to support veterans supported campuses, and HB 2475 that would have incentivized giving a proportion of state contracts to disabled veteran-owned businesses also fell by the wayside.

But Hope Remains for Others

Of the remaining bills HB 2457 is the most important and is doing well. The bill would authorize the presiding judge of each county superior court to establish a regional veteran's court. These are important to provide better opportunity for veterans to receive treatment rather than simply jail time for selected offenses. Among the other bills in work are SB 1312 that would formalize March 29 as Vietnam Veteran's Day (not a legal holiday), SB 1401 that would authorize the building of a memorial dedicated to U.S. submarine veterans and HB 2135 that would continue the Military Affairs Commission.
