

Change is Coming

Earlier this year, a decision was made that will impact all 60,000 surviving spouses in MOAA's membership. The Auxiliary Member Advisory Committee (AMAC) approved a new name for their committee – the Surviving Spouses Advisory Committee (SSAC).

This decision was the result of several years of deliberations over the general feeling that calling surviving spouses auxiliary members failed to adequately describe the significant contributions these members make to MOAA. They are a very important part of MOAA's membership, and Surviving Spouses better describes who they are.

The renaming of the committee, which has for years advised MOAA's Chairman on all matters pertaining to auxiliary members in MOAA, will lead to a new membership category. Auxiliary memberships will be replaced by Surviving Spouse memberships.

New Survivors Planning Guide Is Ready

In a separate development, we told you several months ago that MOAA was in the process of publishing a new *Survivors Planning Guide* to help surviving spouses with the loss of their military member spouse.

Originally set for an April publication, it was delayed and published in September. The new guide contains extensive inputs from surviving spouses on MOAA's Surviving Spouse Advisory Committee. The guide is intended to be used in conjunction with another MOAA publication, MOAA's *Personal Affairs Action Guide*, to provide a sequence of actions that require attention beginning with burial arrangements and then the many other issues that must be addressed.

Legislative Update

God News - Bad News

This month there is some good news but mostly bad news.

The *good news* is that the House and Senate finished work on the FY2016 Defense Authorization Bill early in October and sent it to the President for signature.

The *bad news* is that the bill contained some things MOAA doesn't like and that the President then vetoed it on October 22.

It's especially disappointing that the main sticking point involved a budget technicality, not issues directly related to defense policy. Under the 2011 Budget Control Act, (better known as Sequestration) there are hard caps on both defense and non-defense spending. Most people agree the defense cap is too low and jeopardizes readiness. But the President and many in Congress believe the cap on non-defense spending is too low as well. The debate over whether and how to raise the caps has Congress tied up in knots.

Committee Leaders' Gambit Fails

But a nation at war needs a defense bill, and it needs more money than the cap allows. So House and Senate Armed Services Committee leaders used a technicality to get around the cap. They authorized an extra \$38 billion in a wartime contingency account that's not subject to spending limits. The President vetoed the bill for two main reasons. First, he says (rightly) that using this one-year mechanism fails to let the Pentagon plan for the future. Second, he agrees with many in Congress that it's wrong to let Defense spend above the legal limits while keeping the cap on non-defense accounts.

MOAA Disagrees with Tactic

MOAA believes the defense bill is the wrong vehicle to wage this battle. It only authorizes things; it doesn't provide funding. The funding bills are tied up in a separate political fight that Congress is going to have to work out over the next month or two. At this point, legislators are scheduling votes to override the veto. But that takes a two-thirds majority vote in both the

House and Senate, and most think the votes aren't there. So it looks like the veto will stand until Congress finds a way to untie the budget cap knot.

MOAA Concerns

Some concerned MOAA members have asked, why not use the veto to try to get fixes to some of the things MOAA doesn't like? The reality is that the veto will not reopen any of the things MOAA is concerned about in the bill.

What are those things? Some of the most contentious issues are:

- A 1.3% pay raise for the troops vice the 2.3% needed to keep up with private sector wage growth – the third year that raises have been capped.
- Major changes to military retirement effective in 2018 that will cut retirement by 20%. Current members and retirees are expected to be grandfathered under the old system.
- Major reductions in commissary funding were averted for this year, but the danger is far from over.
- Major changes to TRICARE and new fees were averted, but pharmacy and mail order copays will be going up in 2016.

Those fights have been fought in the Armed Services committees, with compromises reached in the interest of getting a bill passed. There is no chance of any of those things being renegotiated in a Capitol Hill environment that is focused almost exclusively on budget issues. The worst-case veto scenario is that a frustrated Congress could just eliminate the supplemental account and pass a defense bill with \$38 billion less funding.

Alternatively, the defense bill would go back into the roiling pot with the other major budget issues – raising the debt ceiling, figuring out the entire government budget, and funding it through a continuing resolution or some other measure.
