Veterans Heritage Project Honors Vets, Inspires Youth

The Arizona Veterans Heritage Project began in 2003 when Barbara Hatch, VHP founder, brought World War II veterans to her class at Cactus Shadows High School to tell their stories.

Since than the program has grown to 25 participating high schools, and 1,227 veterans have been interviewed by high school students, with their stories published in an annual book titled Since You Asked.

Brittany Henritze, VHP Executive Brittany Coordinator, described the Henritze program at our February luncheon, with the help of

with the help of Harrison Kessel, one of the student authors and this year's book editor, and chapter member Jeanne Blaes, Col USA (Ret), who is featured in this year's edition.

Brittany explained that VHP helps students develop professional and academic skills.

For veterans, it preserves their *Harrison* history and closes the gap between *Kessel* the civilian and veteran communities.

Harrison, a sophomore, has been involved since 8th grade. "It's been the most wonderful experience of my life," he said. "It's a way to say thank you for your service without just saying thank you."

Jeanne, who served in the Medical Service Corps, said it was an opportunity to tell what it was like to be a woman veteran.

"I never thought my story was worth telling," she said. "It didn't hit me until I saw what

Harrison wrote. I can say I felt good about something I did. You see your story and you can say I guess I did okay."

"FEAR, ADRENALINE & EXCITEMENT" Jack Holder

Jack Holder joined the US Navy on April 24, 1940, when he was 18-years-old and was transferred to Pearl Harbor in December 1940. He survived the attack there a year later and went on to experience quite a career in Naval Aviation during and after World War II. He participated in the Battle of Midway in 1942 and flew 48 missions over Guadalcanal and the Solomon Islands for six months. Jack also flew patrol over the English Channel and the Bay of Biscay on the western coast of France. He flew 56 anti-submarine patrol missions over the English Channel.

<u>Jack Holder, 94, is one of the few remaining Pearl Harbor military survivors</u>. We are fortunate to have him speak to us. Please plan to attend this exciting presentation. Jack will have his book by the same title available for purchase after his presentation.

Exchange Online Shopping Opens to Veterans

The following is an extract from an article by military columnist Tom Philpott. After two years of study, the Department of Defense has announced that effective November 11, 2017, a new online shopping benefit will allow 16 million honorably discharged veterans to shop online for discounted military exchange products.

Months of preparation are needed to make eshopping portals more robust and to allow the Defense Manpower Data Center (DMDC) time to create software for verifying veterans' status using Department of Veterans Affairs records. The online benefit does not extend to veterans' dependents. With DMDC verifying shopper identifies electronically, the department will not have to produce special identification cards.

Two Reasons for Change

Thomas C. Shull, chief executive officer of the Army and Air Force Exchange Service, led the effort to expand online exchange shopping to all honorably-discharged veterans with access to computers. There were two reasons for the change. One was to reward veterans' service with exchange product savings that, on average, will be close to 20 percent versus commercial department store prices when military exemptions from state and local sales tax are considered. The second reason was to increase exchange revenues to help offset troubling declines due to the drawdown of active duty forces, base closures and the end of military tobacco discounts.

Exchange System Impacts

The four exchange services will maintain independent websites and separate online portals for the selection of goods they offer. The Veterans Online Shopping Benefit is expected to at least double exchanges' online presence. which will help attract better terms from competitive merchandise vendors. more assortments improved efficiencies. and Exchanges project \$18 million to \$72 million in new annual earnings when the online operation is fully matured. Half of the added earnings would distributed typically be as higher dividends to MWR programs, which have come under increasing budget pressure as the services divert funds to more immediate readiness needs.

Current exchange patrons won't see more store traffic, and discounts for exchange shopping on base are expected to remain higher than savings online. These factors helped to persuade major military associations to back the initiative. Military exchanges acknowledge that they are losing sales to popular online sites such as Amazon, particularly as military patrons grow increasingly comfortable with using smart phones and tablets to shop.

More information will be published over the next few months as implementation details are worked out by DoD.

State Legislation Activity

Two bills of considerable interest to veterans and retirees are currently working in the state legislature. SB 1443 is moving along nicely. SB 1444 is having a tougher time because of loss of revenue to state if the bill passes.

SB 1443: Veterans' Donations Fund; Tax Credit would extend authority for the Military Family Relief Fund (MFRF) from 2018 to 2025 and cap the MFRF at its current level by moving the associated \$1 million per year tax credit to the Veteran Donations Fund (VDF) which, by statute, is to be used "for the benefit of the veterans (of all eras) within this state as grants". The fund is administered by the Arizona Department of Veterans Services. Primary Sponsors: Sen. Gail Griffin, R-Dist. 14; Rep. Richard Andrade, D-Dist. 29, et al.

Major Actions: 31 Jan, First Read and assigned to Senate Finance, Appropriations and Rules Committees; 15 Feb, Given a "Do Pass" recommendation in Finance Committee 4-2-1; 21 Feb, Given a "Do Pass" recommendation in Appropriations Committee 9-0-1.

SB 1444: Income Tax Subtraction; Military Retirement would incrementally reduce Arizona income tax on military retirement pay beginning in tax year 2019 and fully deducting military retirement pay in 2022. Primary Sponsors: Sen. Gail Griffin, R-Dist. 14; Rep. Richard Andrade, D-Dist. 29, et al.

Budget Challenges Ahead

With the new Administration now in place and a new Congress in session on Capitol Hill there is plenty of speculation on what the Trump administration's 2018 budget proposal will look like. The Administration has announced plans to release a proposed budget outline sometime in mid-March for FY 2018. Meanwhile, there is still no approved budget for FY 2017.

The President has stated he is committed to boost spending for the Defense Department, but by how much is not known. Increases in Defense could well mean cuts to domestic programs, likely triggering a budget fight in Congress.

Several key pieces of legislation and critical dates directly affect future budget and spending decisions. The government is currently operating under a continuing resolution that runs out April 28. A decision on raising the debt limit will have to be decided by Congress at around the same time, and the threat of the return in 2018 of the mandatory budget cuts under sequestration looms large.

Congress has several options going forward.

- Vote to repeal sequestration, lifting budget caps and return to regular order in terms of budget and fiscal considerations;
- Come up with another budget deal and find a way to raise the caps; or
- Leave the caps mandated by sequestration in place.

Congress should first find a way to fund the government for the rest of the year, and then take on the FY 2018 budget and sequestration. What Congress will actually do is not clear.

New VA Secretary Takes Charge

Dr. David Shulkin was sworn in February 14 as the ninth secretary of Department of Veterans Affairs after receiving unanimous approval from the Senate. Secretary Shulkin was the former undersecretary of the Veterans Health Administration (VHA).

The new secretary has a tough road ahead of

him, balancing the often competing priorities of Congress, the White House, his own agency, and the veterans he is committed to serving.

His first major action will be to work with lawmakers to extend the Choice Act, legislation allowing qualified veterans to receive care in the private sector. Under current law, the program is set to expire this August. Extending the Veterans Choice Program (VCP) would also give the VA time to put in place a new program to meet the rising demand for veterans' health care brought about since the VCP was established in 2014.

The Choice Act was Congress' answer to the reports of secret wait lists in the Phoenix VA Health Care system in Arizona. Though initially plagued with problems, over time the VA and Congress implemented laws and adjusted policies to make it easier for veterans to access care through the VCP. Today, more than one million veterans have been able to access care thanks to the Choice Act.

MOAA will provide more details on the new program once the contract has been announced.

Commissary Savings Revised

For years, the Defense Commissary Agency (DeCA) told Congress and store patrons that commissary shoppers saved an average of 30 percent on brand-name groceries over prices in commercial stores and supermarkets.

DeCA officials now concede the 30-percent savings figure didn't include price comparisons at Walmart Supercenters or consider the popularity of private-label goods that outside grocers find so profitable.


DeCA has now released a new set of "baseline" estimates of commissary savings that reflect these factors and more. Global savings across all 238 commissaries are calculated now at 23.7 percent and savings stateside at 20.2 percent.

DeCA also is publishing average savings by seven U.S. commissary regions. The 20 commissaries in the Rocky Mountain region, which runs south from the Canadian border through Arizona and New Mexico, had the lowest savings, 17.6 percent compared to prices

off base.

Some advocates for military families fear that the mere perception of lower savings could put commissaries at greater risk. DoD and some members of Congress have been trying to cut DeCA's \$1.3 billion budget for years and may see an opening in the latest savings figures. But the greater concern is how patrons will react to the results. If the perception is that the commissary no longer provides significant savings, they may well shop elsewhere and critics will have more ammunition in cutting the commissary benefit.
