

Legislative Update

Where the FY23 NDAA and Budget Bills Stand

October 1 marks the start of the new fiscal year. Congress is supposed to have passed the appropriate authorization and appropriation bills to keep the government operating. To review, without the necessary authorizations and appropriations, federal agencies can't operate properly. An authorization bill establishes new policies and programs for a federal agency and can reauthorize programs set to expire, while appropriations provide the funding for those authorizations. Once again, Congress has not done their job.

Until Congress passes those bills, federal agencies overseeing the eight uniformed services lack the authorizations or funding needed for the annual military pay raise, quality health care coverage, and quality-of-life programs for servicemembers and their families, along with many other support programs and benefits necessary for an all-volunteer force.

Passing authorization and appropriations bills before the end of the fiscal year has been a recurring challenge. The last year Congress and the White House enacted the necessary legislation on time to fully fund the government for the upcoming fiscal year was for FY 1997.

With the start of FY 2023 here now, and midterm elections coming, it's very likely the government will again miss the mark with its budget process. There is only a little more time for Congress to approve authorizations, up to the end of the calendar year.

Here's where the process now stands:

FY 2023 Authorizations: For MOAA's purposes, the National Defense Authorization Act (NDAA) is the most critical of these bills, as it affects DoD policies and programs. The House passed its version of the NDAA on July 14 by a vote of 329-101. The Senate has yet to pass its version.

FY 2023 Appropriations: Neither the House nor the Senate have passed all 12 of the appropriations bills that make up the federal budget. Of particular interest to MOAA are the defense appropriations bill, which has authority over the budget for DoD, and the Military Construction-Veterans Affairs (MilCon-VA) appropriations bill, which sets the funding for military construction and the VA.

Missing the October 1 deadline for authorizations will have tangible consequences such as delayed implementation of new programs, inability for DoD and other federal agencies to modify or discontinue existing programs, and agency leaders beginning FY 2023 with the challenge of funding newly legislated increases on the previous year's budget.

What's Next?

If Congress and the White House do not enact all 12 appropriation bills by October 1, it could result in a government shutdown. A more likely outcome would be the passage of a continuing resolution (CR), legislation to fund federal agencies so they can continue operating until the full appropriations process is finished. A CR would provide funding to the federal government at last year's spending levels and could include add-ons such as support for the war in Ukraine or necessary funds for other programs throughout the government.

For 25 years, Congress and the White House have failed to enact the necessary legislation to fully fund the federal government on time, and the ones who suffer the most are servicemembers, veterans, survivors, and their families. MOAA will continue to engage with members of Congress to ensure the needs of the uniformed services and veteran communities are fulfilled now and into the following year.

Recent Chapter Events

Tony Pistilli of Fountain Hills spoke to our chapter in May as a Colonel representing Airbase Arizona of the Commemorative Air Force, Mesa, AZ, at Falcon Field. Tony has worked for America West Airlines as Senior Director of Operations Planning, and in 1999 he joined United Airlines as Director of Maintenance Programs. He retired in 2007, and has remained busy: He is the past President of the Rotary Club in Fountain Hills and remains active, worked in the Junior Achievement program at the local High School, and is a docent at Air Base Arizona.

Tony gave a fascinating and educational program for our members. As a docent at Air Base Arizona, he is no stranger to talking in front of groups. Tours at the Air Base often have 200 visitors on any given Saturday. The facility is open Wed-Sat in the summer; the hours are 10AM-4PM. The Commemorative Air Force has 88 units worldwide (bases) with 173 Aircraft. Tony told the group his father was a crew chief in the Pacific Theater in WWII. Following the end of WWII, a group of investors from the Southeast began the Confederate Air Force in order to save many WWII airplanes from being recycled (for scrap metal). The name was later changed to Commemorative Air Force; its mission is to acquire, restore, display, and preserve aircraft. They have restored six WWII airplanes to flying status and over 20 others in the Museum. Rides in these aircraft can be purchased. The museum collection contains 25 aircraft from pre-WWI to the Vietnam War.

Air Base Arizona is one of the largest bases in the system and has 400 volunteers. Tony said their fleet leaves for the summer for bases where the weather is cooler. Tony shared that the volunteers actually teach history, and he is very active in giving historic presentations at the Air Base as well as local community meetings.

Chapter Happy Hour Meeting - 20 Sep 2022

Our chapter had its first actual meeting on a weekday evening with a speaker and dinner on September 20, 2022 at the American Legion Post 44 in Scottsdale. The purpose was to potentially allow younger members to attend who may not be able to be present at our regularly scheduled Saturday luncheons.

The jury is still out on the success of this meeting for that intended purpose, however the speaker that evening, Brian Minzey, was in a word, *outstanding!* Brian's military career spanned both the Navy and Army, and he shared his story as being one of the first responders to a deadly Air Force CV-22 Osprey crash in Afghanistan in 2010. The personal impact that this event had on Brian's life has been substantial, and we were honored to be the first group that he has spoken publicly to since that event. Brian gave a very emotional presentation about his military career leading up to that incident and his ability to become one of the Army's most elite soldiers - an Army Ranger. This is the Army's premier direct-action raid force.

Along the way, Brian met up with Brigadier General Don Harvel who was the Chief Accident Investigator of this Osprey crash. With this mutual experience they bonded, and prior to Don's untimely passing they were comrades in arms. Brian is to be commended for his motivation and willingness to face his PTSD and to speak in public to our chapter after all these years. Everyone who attended was deeply moved by his sincerity and positive attitude.

Also attending that evening were Brian's wife, Megan and Don Harvel's daughter Randee and her fiancé. Don's book, *Rotors in the Sand* was available and with Randee's signature.

RMD Strategy for a Down Market

This month's column is an extract from an article written by MOAA editor Rachel Reedy. Several times in past economic downturns, the federal government has suspended Required Minimum Distributions (RMDs) for retirement accounts for the year. In 2020, RMDs were suspended to help provide relief during the COVID pandemic, and RMDs were waived for 2009 during the Great Recession. This doesn't happen very often.

Right now, we are waiting to see what the government might do. One option while you wait is to take your RMD closer to year-end to see if any reprieve is granted. But if there is no suspension of RMDs, and you don't need the money to cover expenses, there is an option that can help you avoid locking in losses while still taking your RMD — the in-kind transfer.

Ask your account custodian to do an in-kind transfer of investment shares to a taxable brokerage account in an amount that equals the value of your

RMD. You will still pay ordinary income tax on the RMD amount. But instead of cashing out the shares and locking in losses in a down stock market, the shares can grow in the taxable account when the market bounces back.

After the shares have been transferred in kind, doublecheck with your custodian that the total transfer value meets your RMD amount. You want to ensure that investments that were valued at the market close price on the day of transfer didn't fluctuate lower than you expected.

If the transfer fell short of your RMD, you'll need to move more shares or withdraw cash from the retirement account to make up the difference so that you satisfy your full RMD. That way you'll avoid being subject to a penalty worth 50% of the RMD shortfall.

Your basis in the shares will be the value on the date of transfer. When it comes time to sell the shares from the taxable brokerage account, you'll owe tax on any appreciation. If the shares instead end up with your heirs, the shares' basis will jump up to the value on your date of death — with any appreciation being tax free for your heirs.

Be sure to consult with your investment advisor to help you with the details of this strategy.
